

What is Vocational Rehabilitation (VR)?

- ▶ Vocational Rehabilitation is a statewide program that helps eligible people with disabilities of all ages (and potentially eligible students) prepare for, find, and keep employment.
- ▶ To be eligible, you must have a disability that keeps you from getting and keeping a job – and – you must need VR services to overcome disability-related barriers.

Workforce Innovation and Opportunity Act (WIOA) Pre Employment Transition Services

1. Job Exploration Counseling
 2. Work-based Learning Experiences
 3. Counseling on Opportunities for Post-Secondary Training and Education
 4. Workplace Readiness Training to Develop Social Skills and Independent Living
 5. Instruction in Self-Advocacy

What We Know - Paid Work Experience Matters

- ▶ From the National Collaborative on Workforce and Disability for Youth (NCWD/Youth) – Practice Brief: *Engaging Youth in Work Experiences* (Sept. 2011)
 - “Families who learn about and begin the career development process with their youth early will be **better prepared** to support them in choosing and building a bright future.”
 - “Students who participated in work-based learning were **more likely to attend college or go to work** compared to their peers (Jobs for the Future, 2007).”
 - “One of the most important findings from the research shows that work experiences for youth with disabilities during high school (paid or unpaid) help them **acquire jobs at higher wages** after they graduate (Colley & Jamison, 1998).”
 - “In addition, research studies suggest that work-based learning may **increase school attendance, decrease dropout rates**, reduce school suspensions, and increase school engagement (Medrich, Calderon, & Hoachlander, 2002)”

Pressing Issues for Maine

- ▶ Who will be the next generation of workers?
 - ▶ What will work look like?
 - ▶ How can jobseekers with disabilities be part of the solution?

Progressive Employment

- ▶ “Everyone is ready for something”
 - Early engagement
 - Informational interviews, job shadows, paid work experience
 - Different way of partnering with the business community
 - Serving transition-age youth and young adults in Portland and Lewiston
 - Partnering with Community Rehabilitation Providers
 - Over 500 Progressive Employment activities to date!

Progressive Employment Stories

- ▶ Examples from the Portland and Lewiston offices

Early Progressive Employment Evaluation – Institute for Community Inclusion (ICI) – Jan 18

- ▶ The successful closure rate of PE transition youth was nearly 48%
- ▶ Reducing early exit : Preliminary data suggest that this approach is very promising
- ▶ Approximately 89% of 363 PE work exposures were classified as low dose, as the experience lasted one day or less.
 - Median successful closure = 4 activities
 - Median unsuccessful closure – 2.5 activities

The Transition Work Based Learning Model Demonstration Grant

- ▶ What: **Disability Innovation Fund: Transition Work-Based Learning Model Demonstration Grant (CFDA Number: 84.421B)**
- ▶ Length of Grant: **5 years** (began October 1, 2016)
- ▶ Amount of Funding: **\$9 million**
- ▶ Funder: **Rehabilitation Services Administration** (part of the US Department of Education – Office of Special Education and Rehabilitative Services)
- ▶ Purpose: Provide **effective work-based learning experiences** (at least 2 per student) in coordination with other transition services, including pre-employment transition services and customized employment, to students with disabilities to ensure that those **students are prepared for postsecondary education and competitive integrated employment.**

Grant Purpose/Goals

- ▶ Serve students who are within two years of high school graduation or exit
 - Bangor and Augusta catchment areas
 - ▶ Evaluate the effectiveness of two interventions
 - “Enhanced” Jobs for Maine’s Graduates programming
 - Progressive Employment
 - ▶ Develop replicable, sustainable and collaborative ways to provide pre-employment transition services to youth with disabilities
 - ▶ Within 1 year after graduation at least 90 percent of study participants will enter postsecondary education/training or competitive integrated employment.

Strategies

- ▶ Expand JMG programs to five new high schools in the Bangor area
- ▶ Cross-train all JMG Specialists as ACRE-certified Employment Specialists
- ▶ Launch “Progressive Employment” in the Augusta and Bangor catchment areas
 - Build new relationships with local employers
- ▶ Provide additional transition resources (Rehabilitation Counselor I’s) to provide direct services to students and coordinate with VR Counselors as well as provide support to JMG Specialists on disability and inclusion
